Attention Local 7 Members Working for King Soopers and City Market:

The majority of the Retail and Meat contracts are due to expire on January 12, 2019. Despite my request to bargain early, the Company has agreed to only two (2) bargaining dates prior to the expiration of the contracts. The Company has agreed to meet on December 18, 2018 and January 3, 2019. Two (2) bargaining sessions is not enough time to reach a good and fair contract. We will continue to push for additional dates.

The Company has continued to grow their online ordering and delivery business by outsourcing jobs to third party entities, such as Instacart, Doordash, Shipt, and King Soopers Ship. The Company is also reducing their need for workers by expanding their use of technology and automation with their new Scan Bag and "JOBS" Go, robotically operated warehouses, Parata Pharmacy Robots, and digital tags. The automating and outsourcing of jobs has a negative impact on the future of good jobs, but will also affect the sustainability of our health and pension plans. We must stand together and fight for a contract that protects and guarantees jobs for all UFCW Local 7 members.

Local 7 has continued to identify and grieve safety hazards in the stores. We have filed hundreds of grievances over unsafe working conditions; however, the Company continues to make workers and the customer's safety a non-priority. It is the Company's obligation to provide a safe workplace. The terms in a new contract must ensure that the Company is held accountable for a safe work environment.

The Company has received massive tax breaks, in addition to increased profit they will make due to new sales of full strength malt liquor. The Company will also be allowed to apply for additional liquor licenses, which will also increase their record profits. The Company can afford to provide significant across-the-board wage increases, ensure continued quality and affordable healthcare, and a good pension for all its workers.

Kings Soopers – City Market is the number one chain in the state holding the majority of market share for retail grocery in Colorado. We must remind them that their workers are responsible for every bit of the Company's success. It is time that they share their success with their workers; after all, it is their workers, our UFCW Local 7 Members, who make the difference! Make no mistake; Colorado's Kroger Division is a jewel in the crown of Kroger, who is the largest retail grocer in the country. You deserve a larger slice of their profit because it is your hard work that makes them successful.
